TERMS AND CONDITIONS

1. Under the terms and conditions of this agreement (the "Agreement"), the name ("Group Leader") identified on the attached 2024-25 Bucks Group Priority Form (the "Form"), on behalf of the company/group identified on such Form ("Group"), acknowledges and agrees that the Group will receive certain priority and other benefits and incentives in exchange for making an initial non-refundable payment (an "Initial Payment") towards one (1) group ticket purchase package ("Group Package") for one (1) Milwaukee Bucks (the "Bucks") regular season home game during the 2024-25 NBA season ("Home Game").
2. The Group acknowledges and agrees that on or before April 1, 2024 (the "Conversion Date"), the Group must notify the Bucks (orally or in writing) that the Initial Payment will be applied, in full, towards the following: (i) a Group Package for one (1) 2024-25 Bucks Home Game, with the remaining balance of the Group Package for such Home Game to be paid in full thirty (30) days prior to the date of the selected Home Game; (ii) single-game tickets for Home Game(s) during the 2024-25 NBA season; and/or (iii) as an Initial Payment for a Group Package for Bucks regular season home games during the 2025-26 NBA season.
3. The Group further acknowledges and agrees that (i) the Group Package shall be subject to availability and to additional terms and conditions to be presented at the time of purchase of the Group Package; (ii) neither the Bucks nor any of its affiliates has made any warranty, representation, covenant or guarantee that the Group will receive a specific Home Game, fan experience, or a specific location at a Home Game in connection with the Initial Payment or the Group Package; and (iii) the Initial Payment is non-refundable, such that if the Group does not (x) apply the Initial Payment in full in the manner described in Paragraph 2 above on or before the Conversion Date and/or (y) complete full payment of the Initial Payment by the Conversion Date, the Bucks shall have the right to retain the Initial Payment, or the remainder of the unused Initial Payment, as the case may be, as liquidated damages to compensate the Bucks for expenses and losses caused by such non-use and/or non-payment of the Initial Payment.
4. The Bucks retain the right at any time to revoke or cancel any Group Package tickets by refunding the actual amounts paid for such tickets, excluding the Initial Payment. The rights and obligations of the Group hereunder are not assignable or transferable without the prior express written consent of the Bucks. All holders of tickets shall also be subject to the terms and conditions of each individual game ticket purchased as part of the Group Package, as well as the Milwaukee Bucks Ticket Purchase Terms and Conditions (available at: <https://www.nba.com/bucks/tickets/purchase-terms-and-conditions>). The Group Leader acknowledges and agrees that he/she is an authorized representative of the Group and has full power and authority to make the commitment and Initial Payment referenced on the Form on behalf of the Group.
5. The sale or resale of Group Package tickets by unauthorized means is prohibited and violation of this policy may result in the cancellation or revocation of unused or unissued Group Package tickets. Group Package tickets may not be resold without the prior express written consent of the Bucks. In addition, Group Package tickets may not be used for advertising, promotion (including contests or sweepstakes) or other trade purposes without the prior express written consent of the Bucks.
6. The Bucks reserve the right in their sole discretion to amend, update, or modify policies and procedures relative to Group Packages and Initial Payments, and such information may be posted on www.nba.com/bucks from time to time.
7. This Agreement shall be governed by and construed in accordance exclusively with the laws of the State of Wisconsin without regard to its conflicts of law rules. The parties hereby agree that any claims or disputes regarding this Agreement shall be submitted to arbitration in Milwaukee, Wisconsin under the rules of the American Arbitration Association.
8. If the Initial Payment is to be paid by credit card(s), the Group agrees to "Automatic Initial Payment Authorization" ("APA") thereby authorizing the Bucks to charge the credit card(s) listed to pay the amount listed on the Form. The card(s) must have a valid expiration date for the duration of the APA process. All sales are final and non-refundable once the Initial Payment is accepted by the Bucks. The Bucks reserve the right to assess a service charge of \$15.00 on all declined transactions. If a credit card declines for any reason, Group Leader agrees that he/she will be responsible for paying any remaining balance as well as any declined transaction fee.
9. The Group shall indemnify, defend and hold harmless the Bucks, Deer District LLC, the National Basketball Association and its Member Teams, Wisconsin Center District, Fiserv, Inc., and each of their respective affiliates, owners, officers, directors, employees and agents (collectively, the "Indemnified Entities"), from and against all claims, demands, liabilities, losses, damages, costs and expenses, including, without limitation, reasonable attorneys' fees and expenses, arising from the Group or Group's guest(s)' use of Group Package tickets, or the negligent acts or omissions of the Group or the Group's guests. In no event shall any of the Indemnified Entities be liable for consequential or indirect damages.
10. This Agreement provides for the exclusive resolution of disputes through individual arbitration on the Group's own behalf instead of through any class or representative action. Even if the applicable law provides otherwise, the Group agrees that any arbitration against the Bucks or its affiliates shall be arbitrated by the Group individually and not as a member of any class or as part of a class or representative action, and the Group expressly agrees to waive any law entitling the Group to participate in a class action. If the Group's claim is subject to arbitration under Paragraph 7 above, the arbitrator shall have no authority to arbitrate claims on a class action basis. The Group agrees that this class action waiver shall not be severable under any circumstances from the arbitration clause set forth in Paragraph 7 above, and if for any reason this class action waiver is unenforceable as to any particular claim, then, and only then, such claim shall not be subject to arbitration.
